

Highlights

- **SDKs:** Scheil calculations, phase diagrams and property diagrams now available with TC-Python.
- ★ Databases: New database versions of TCS Metal Oxide Solutions (TCOX8) and TCS Mg-based Alloys (TCMG5), plus an update to the TCS Al-based Alloy Database (TCAL5).
- ★ Thermo-Calc plus the add-on Diffusion (DICTRA) and Precipitation (TC-PRISMA) modules: A variety of bug fixes, including to the Quick Start Wizard and an improved interfacial energy function.

TC-Python API

New Features: Scheil Calculations, Phase Diagrams, and Property Diagrams

This release of TC-Python adds three important features: Scheil calculations, phase diagrams and property diagrams.

TC-Python is a Python[™]-based SDK introduced in Thermo-Calc 2018a that allows users to couple Thermo-Calc calculations with other software in an open way. The SDK is built in the popular language Python[™] to give Thermo-Calc users access to many other programs, such as numerical packages like NumPy and SciPy, which can now be used in combination with our calculations.

Several new examples are included with this release. You can use these examples to both learn about the use of TC-Python and as a way to build your own calculation simulations. The documentation is also updated to include best practices to work with TC-Python as well as detailed information about the additional features.

Scheil Calculations


Thermo-Calc is primarily a program for performing equilibrium calculations, but some non-equilibrium transformations or partial-equilibrium transformations can be simulated. One example of such a transformation is a Scheil-Gulliver solidification. A Scheil calculation results in an estimation of the solidification range of an alloy.

Using TC-Python, everything that can be configured in the **Scheil Calculator** in Thermo-Calc Graphical Mode, as well as many of the available settings in the **Scheil module** in Console Mode, can be done. The minimum you need to specify are the elements and their composition. Everything else is set to a default value if you do not explicitly specify it.



 Five new examples: Scheil Mole Fraction of a Solid (pyex_T_03), Scheil Composition Distribution (pyex_T_04), Scheil Composition Profiles in a Solidified Ni-based Superalloy (pyex_T_05), Scheil Calculation of an Eutectic Fraction (pyex_T_06), and Scheil Solidification Simulation - Export to CSV (pyex_T_07).

The following plot is the result of running example 5, *Scheil Composition Profiles in a Solidified Ni-based Superalloy* (pyex_T_05_Scheil_composition_profiles_Ni_base.py). This example calculates the microsegregation profile in a solidified Ni-based superalloy using the Scheil-method. The plot is normalized relative to the nominal composition and shows the composition of the matrix phase (FCC). A model alloy in the system Ni-Al-Cr is used as an example.




Phase Diagrams

Phase diagrams have two or more independent axis variables. For the phase (map) diagram calculations, everything that you can configure in the **Equilibrium Calculator** when choosing *Phase diagram* in Thermo-Calc Graphical Mode can also be configured in this calculation. In Console Mode the phase diagram is created using the Map command. The minimum you need to specify are elements, conditions and two calculation axes. If you do not specify otherwise, everything else is set to default values.

• *New examples:* Calculating and Plotting a Phase Diagram (pyex_T_11), Exporting Phase Diagram Data to a CSV File (pyex_T_12), and Calculating a Single Phase FCC_A1 Region Shift (pyex_T_13).

The plot is the result of running example 11, *Calculating and Plotting a Phase Diagram* (pyex T 11 Phase diagram.py) where the system Fe-Cr is used as an example.






Property Diagrams

When you calculate and plot a property (step) diagram, there is only one independent state variable. Many different properties can be plotted as a function of this independent variable. For the property diagram (step) calculations, everything that you can configure in the **Equilibrium Calculator** when choosing *Property diagram* in Thermo-Calc Graphical Mode can also be configured in this calculation. In Console Mode the property diagram is created using the Step command. The minimum you need to specify are elements, conditions and the calculation axis. If you do not specify otherwise, everything else is set to default values.




The plots shown are the result of running example 10, *Creating property diagrams* (pyex_T_10_Property_diagram_alloy_A_to_alloy_B.py). The example shows how to perform step calculations to create property diagrams. The plot results for this example show a section between two materials when moving from one material composition to another. On the left side of each diagram it is one alloy and on the right side it is another alloy.






Fe-Cr-Ni-C-Mn, phase fractions at 1000 K between the two alloys





A phase diagram for the same section as the property diagram but with the temperature on the y-axis.





The last plot included with this TC-Python example shows how compositions vary linearly along the section. This is a step from one material composition to another.

Bug Fixes

- Fixed an issue that caused the calculation log messages to stop appearing during simulations with TC-Python.
- Improved the validation of the mandatory input parameters for precipitation simulations.

Precipitation Calculations in TC-Python

- Fixed an issue with case sensitivity when defining a dependent element. Also fixed an issue with not allowing all compositions of a phase as matrix phase although these have diffusion data.
- Fixed a bug so that the get_matrix_composition_in_mole_fraction_of method returns weight fraction.

Updating TC-Python from 2018a to 2018b

Note the following if you installed the first version of TC-Python with Thermo-Calc 2018a. When updating to a newer version of Thermo-Calc, you always also need to install the latest version of TC-Python. It is not sufficient to run the installer of Thermo-Calc. See the section "Updating to a newer version" in the *TC-Python Quick Installation Guide*. Databases

New Version of the TCS Metal Oxide Solutions Database (TCOX8)

Summary of the changes between TCOX7 and TCOX8

- Addition of 6 new elements: Co, Mo, P, V, W, Ar (only in gas). Now in a 24-element framework.
- Co: Assessed or added from literature all binary and a few ternary metallic systems. Added/Assessed Co-F, Co-O and Co-S. Assessed 29 ternary Co-Me2-O, Co-Me2-S and Co-Me2-F systems and 13 higher order oxide systems as indicated in the TCOX information sheet.
- Mo: Assessed or added from literature all binary and a few ternary metallic systems. Added/Assessed Mo-O and Mo-S. Assessed 6 ternary Me1-Mo-O and Me1-Mo-S systems as indicated in the TCOX information sheet.
- P: Assessed or added from literature all binary and a few ternary metallic systems except F-P, Gd-P, La-P, Mg-P, P-V, P-W and P-Zr. Assessed 18 ternary Me1-O-P systems and 11 higher order oxide and oxy-fluoride systems as indicated in the TCOX information sheet.
- V: Assessed or added from literature all binary and a few ternary metallic systems except P-V and S-V. Assessed 13 ternary Me1-V-O systems as indicated in the TCOX information sheet.
- W: Assessed or added from literature all binary and a few ternary metallic systems except Ca-W, F-W and P-W. Assessed 13 ternary Me1-W-O systems as indicated in the TCOX information sheet.
- The following systems have been assessed for version 8: CaF₂-CoF₂/CrF₃/MnF₂, CoF₂-GdF₃/MgF₂/NiF₂, FeF₃-NiF₂, GdF₃-YF₃, LaF₃-ZrF₄, Al-Cu-S, Al-La-S, Ca-Y-S, Al-Ni-S and Cr-Ni-S.
- The following systems have been reassessed for version 8: F-Fe, Mg-Ni-O-Si, CaO-NiO-SiO₂, Mn-Ni-O, Al-Ni-O, Mn-Si-O, Al-Mn-Si-O, Al-Fe-Mn-Si-O, Ca-Mn-Si-O, Ni-Si-O, Ca-Ni-Si-O, Mg-Ni-Si-O, Al-Cu-O, Al-Cu-Si-O
- The following systems have been estimated for version 8: La-Mg-S, Mn-Zr-S, Gd-Mg-S, Fe-Zr-S, Fe-Gd-S, Fe-La-S, Cu-La-S, Cu-Si-S, Nb-S, Fe-Nb-S
- The large complex gaseous phase has been removed. A reduced gaseous mixture is used including only the important species. If a complete gas is needed, it should be appended from the SGTE substance database.
- α-Ca₂SiO₄ and α'-Ca₃P₂O₈ is merged into one phase. Reassessed solubility of Fe, Gd, Mg, Mn and Y due to change of models.
- Removed Ni-solubility in Corundum.

New Version of the TCS Mg-based Alloys Database (TCMG5)

Summary of the changes between TCMG4.0 and TCMG5.0

- 7 new elements added: Dy, Er, Ga, Ho, In, Sb and Sm.
- 9 Mg-containing binary systems are assessed: Mg-Dy, Mg-Er, Mg-Ga, Mg-Ho, Mg-In, Mg-K, Mg-Sb, Mg-Sm and Mg-Th. Ag-Mg is remodelled.
- 25 non-Mg binary systems are assessed: Ag-In, Al-In, Ca-In, Ce-In, Cu-In, Fe-In, Gd-In, Gd-Sm, In-K, In-La, In-Li, In-Mn, In-Na, In-Nd, In-Ni, In-Pr, In-Sc, In-Si, In-Sn, In-Sr, In-Th, In-Y, In-Zn, In-Zr and Sm-Zn. Most of these are In-containing.
- 11 ternary systems are modelled: Mg-Ag-In, Mg-Ag-Sn, Mg-Al-In, Mg-Cu-In, Mg-Gd-Sm, Mg-In-Li, Mg-In-Sn, Mg-In-Zn, Mg-Sn-Zn, Ag-In-Sn and In-Sn-Zn. Ag-Gd-Mg is remodelled.



• These systems are also updated: Al-Mg-Zr, Mg-Pr-Y, Mg-Si-Sn, Cu-Li and Cu-Li-Mg.

Updated version of the TCS Al-based Alloy Database (TCAL5)

Changes between TCAL5.0 and TCAL5.1

Updates to the following systems:

- Al₆(Cu,Fe,Mn) remodelled in Al-Cu-Fe-Mn and treated as a metastable phase in Al-Cu-Fe.
- Improved description of Al₇Cu₂Fe.
- Updated Si-Ti and Al-Si-Ti.
- Improved volume description.

Thermo-Calc

Improvements and Bug Fixes

Both Graphical and Console Mode

- Improved the visualization of property diagrams calculations where a failure at a single point could appear as a spike in the plot.
- Fixed an issue which prevented some buttons from displaying the state of the button correctly, for example whether the button had been pressed or not.
- Scheil calculations now give a reasonable error message if the start temperature is not in the fully liquid state.
- Fixed a bug where previously you could not perform a calculation after you cloned a tree from the System Definer. Also fixed a bug that produced an when opening the project file with the cloned tree.
- Fixed failing calculations (NullPointerException) that occured in some special constellations in the GUI if components were involved.
- The function to calculate interfacial energy between two phases has been improved so that it is no longer sensitive to which phase is set as matrix and precipitate. This effects the *Interfacial energy model* in the **Property Model Calculator** (Thermo-Calc Graphical Mode), the TQ-Interface function tqgse, and interfacial energy calculations made by in the Precipitation Module (TC-PRISMA) if the interfacial energy is set to "calculated".
- Fixed a bug that occurred when loading a material file containing components that are not linearly independent.

Graphical Mode

Quick Start Wizard

- Fixed a bug related to database packages. Previously, if you started the wizard and already had a database package selected you could not change these. Related to this, fixed some missing *Add* and *Remove* database buttons and combination boxes on the System Definer.
- Fixed a bug in Linux OS related to switching between databases that would throw an exception error.
- Fixed a bug where the program would hang after pressing the back button.



- There was inconsistent behaviour when switching between material and elements. For example, both material components and elements would be selected at the same time.
- Fixed a bug where cancelling mid-way through did not remove the activity nodes already added to the Project window.
- Fixed a bug where after switching databases the available elements did not update correctly and the program would hang. A bug was also fixed where the initial default database would be used in error during a calculation even after switching to a different database.

Other

- Fixed an issue in the project files when using u-fraction in the Plot Renderer. Previously, the chosen component in the denominator was not remembered when saving and then reopening a project file.
- Fixed a bug that prevented the Table Renderer working correctly when used with the Property Model Calculator, *Equilibrium model*.

Console Mode

• Fixed a bug with the Add_Composition_Set command that could cause severe problems if a phase in the system had mobility data.

Diffusion Module (DICTRA)

Improvements and Bug Fixes

Graphical Mode

Fixed an issue when using results from a saved diffusion simulation. The results can now be visualized. It is not possible to resume the calculation and you now get a warning in the **Event Log** window if trying to do so.

Precipitation Module (TC-PRISMA)

Improvements and Bug Fixes

Fixed a bug that created an exception related to adding plot labels to the results of a precipitation calculation plot. Also fixed issues with some pre-existing particle size distributions (PSD) not having any effect on the calculation.

Installation

If you have Linux or Mac initialization scripts in place, please note that the script has changed slightly as follows.



Linux License Initialization Script

The Linux license initialization script has changed from:

```
$ sudo sh license-initialization-linux-x86 64.sh
```

to

\$ sudo sh license-initialization-linux.sh

Mac License Initialization Script

The Mac license initialization script has changed from:

```
$ sudo
/Applications/Thermo-Calc-[version].app/Contents/Resources/license
-initialization-MacOS-x86_64.sh
```

to

```
$ sudo
/Applications/Thermo-Calc-[version].app/Contents/Resources/license
-initialization-MacOS.sh
```

Installation Disk Space Requirement

Due to precompiled databases added to the Thermo-Calc installation, 2 GB of disk space is recommended for the installation.

Platform Roadmap

Windows 32-bit is no longer supported.
